



## **Bills Signed into Law** **November 2003**

**Total number of bills and resolutions signed into law in November 2003: 32**

**Total costs of bills signed into law in November 2003:**

- Authorizations over five years: **\$401.4 billion**
- Net increase in mandatory spending over five years: **\$14.1 billion**
- Appropriations for fiscal year 2003: **\$0**
- Appropriations for fiscal year 2004: **\$116.8 billion**
- Net change in federal revenue over five years: **+\$772.0 million**

*Public Law 108-131*

To authorize the Secretary of the Interior to acquire the property in Cecil County, Maryland, known as Garrett Island for inclusion in the Blackwater National Wildlife Refuge

Signed into law: November 22, 2003

Signed into law: November 22, 2003

Cost: Increases mandatory spending by \$8.0 million over five years and increases revenues by \$1.0 million over five years

To reauthorize certain school lunch and child nutrition programs for fiscal year 2004

Signed into law: November 22, 2003

Cost: Increases mandatory spending by \$7.0 million over five years

Signed into law: November 22, 2003

Cost: No increased spending above the baseline

*Public Law 108-136*

National Defense Authorization for Fiscal Year 2004

Signed into law: November 24, 2003

Cost: Authorizes \$401.3 billion for FY2004, increases mandatory spending by \$14.0 billion over five years, and increases revenues by \$34.0 million over five years
