Dear Colleague:

Current federal regulations deny parents the right to know when their minor daughters receive contraceptive drugs and injections from federally funded family planning clinics.

HR 2444, the Parent's Right to Know Act requires that written notice be provided to parents at least five business days before contraceptive drugs and devices are distributed to their minor daughters by a Title X clinic.
